Dogs in cars on hot days

Your dog is vulnerable and at risk during hot weather and the Kennel Club offers the following guidance to help you through the do's and don'ts travelling to and whilst at KC licensed events.

1, When travelling to a show please take a moment to consider whether the route to the show is on a busy holiday route, and leave earlier to avoid increased time in traffic jams.

2, Ensure your dog is not sitting in full sunlight. There should be plenty of free flowing air around the dog.

3, Keep the dog in the shade – take your own shade for example a large umbrella and always have plenty of water available to drink so your dog stays well hydrated.

Remember, if you feel hot your dog is very likely to feel much hotter and dehydrated, and this could lead to dire results. Please look after your dog's welfare.

If your dog is found to be at risk, forcible entry to your vehicle may be necessary without liability for any damage caused.

Anyone whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not put a dog's health and welfare at risk by any action, default, omission, or otherwise, breach of Kennel Club Regulations in this respect may be referred to the General Committee for disciplinary action under the Kennel Club Rules and Regulations.

Right to Refuse Entries : Competitors are reminded that societies have the right under Kennel Club Regulation to refuse any entry.

All persons attend the Trial at their own risk.

ENTRIES CLOSE: 2nd March 2026

Rules and Regulations

1. Dogs entered at Kennel Club licensed Working Trials must be registered at the Kennel Club in accordance with Kennel Club Regulations for Classification and Registration B.
2. The Committee reserves to itself the right to refuse entries.
3. All dogs resident outside the UK must be issued with a Kennel Club Authority to Compete number before entry can be made. All overseas entries without an AC number will be returned to exhibitor/competitor.
4. The order of running shall be determined by a draw and the competitors notified accordingly by post of their reporting time prior to the day of the Trial.
5. Entries will be accepted by post or online as per the front page.
6. Dogs under 18 months of age on the entry closing date are ineligible for entry competition at Kennel Club licensed working trials except that dogs of 6 calendar months of age on the closing date of the trial may be entered for Special Stakes, which do not include the long, clear jumps and scale.
7. A dog must not compete in the same stake more than once , including special stakes
8. Spayed bitches and castrated dogs may compete at the Trial.
9. The mating of bitches within the precincts of the competition is forbidden.
10. One close fitting smooth collar must be worn, providing the only attachment is a form of identification. Dogs must not wear any type of slip or half-slip collar when under test.
11. Should circumstances so dictate the Association, in consultation with the judges, may alter arrangements as necessary. Such changes and circumstances surrounding them must be reported to the Kennel Club.
12. No dog suffering from any infectious or contagious disease or having been exposed to such disease during the period of 21 days prior to the trial may compete. Competitors infringing this Regulation will be liable to be fined and/or dealt with under Kennel Club Rule A11.
13. Judges at a Trial are prohibited from entering a dog which is recorded in their ownership or part ownership. Dogs will be disqualified if proved to have been handled in the stake by the scheduled judge's spouse or immediate family or resident at the same address as the scheduled judge..
14. If entries in the Companion Dog (CD) Stake exceed 20, a second judge may be appointed to judge the Group IV exercises, and competitors notified accordingly.
15. Not for competition entries are not accepted.
16. A competitor whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not knowingly put their dog's health and welfare at risk by any action, default, omission or otherwise. A breach of this Regulation may be referred to the Board for disciplinary action under Kennel Club Rules and Regulations. The use of pinch collars, electric shock collars or prong collars is not permitted at any Working Trials event licensed by the Kennel Club. This shall apply at the venue and within the precincts of the trial.
17. OWNERS LIABILITY: Owners must accept fully liability for any injury to persons or property caused by their dogs, and entries are accepted on the basis of owners indemnifying EAWTTS and its officers against all claims in respect thereof.
18. In the event that the trial is cancelled due to unforeseen circumstances, the society will refund fees, less reasonably incurred expenses.
19. All dogs compete at owner's risk. The Society and its officers will not be held responsible for any loss or damage arising

Classification and Definitions of Stakes

COMPANION DOG STAKE (CD)

For dogs which have not qualified WDEx

UTILITY DOG STAKE (UD)

For dogs which have been awarded a Certificate of Merit in an Open UD Stake. A dog is not eligible for entry in this Stake if it has qualified WD Excellent or is entered in the WD Stake at the same trial.

WORKING DOG STAKE (WD)

For dogs which have qualified CDEx & UDEx & have been awarded a Certificate of Merit in an Open WD Stake or qualified WDEx. A dog is not eligible for entry in this Stake if has qualified TD or PD Excellent or entered in the TD or PD stake at the same Trial.

TRACKING DOG STAKE (TD)

For Dogs which have been awarded two Certificates of Merit in Open TD stakes and have qualified WDEx at two Championship trials.

PATROL DOG STAKE (PD)

For dogs which have been awarded two Certificates of Merit in Open PD Stakes and have qualified WDEx at two Championship Trials..

SPECIAL NOVICE STAKE

For dogs at least 6 months old on closing date, not qualified in any stake and not entered in any other stake at the trial

When entering Championship or Open working Trials wins at Member Working Trials will not count.

Societies may schedule stakes other than those defined above. The eligibility for 'special stakes' must be defined by the society and included in the schedule. The word 'special' must be included in the title of the stake.

No Working Trial Stake shall be limited to less than 30. If a limit is imposed on entries in a Stake, it shall be carried out by ballot after the closing date for entries.
